### APPLICATION

During the court hearing held on 22 February, 2018, of criminal case number EAKD/0239/01/16, examined within proceedings of the Court of General Jurisdiction of Yerevan, advocate Hrant Ananyan presented to presiding judge M. Martirosyan a copy of a letter of attorney dated to 17/02/2018, which, as announced by advocate H. Ananyan, was the copy of the letter of attorney of Saro Mark Meras and Suren David Meras, the sons of the victim of the same case, the deceased Arpi Meras. The mere visual comparison of the signatures set before the names of Saro Mark Meras and Suren David Meras in the presented copy of the letter of attorney with those in the copies of their passports presented by H. Ananyan has made it evident that the signatures existing in the copy of the letter of attorney does not have any commonality with those put in the passports by the same people and are completely different.

The difference of the signatures in the letter of attorney in other documents presented by Hrant Ananyan give rise to a reasonable suspicion on the fact that the submitted letter of attorney was signed not by Saro Mark Meras and Suren David Meras but by a person or people other than they, which in its turn proves that a forgery was made by the person/s signed the letter of attorney.

Besides, on 20/07/2015, a report on crime by Arpi Meras was logged in Yerevan City Department of the the Police of Armenia, and during the preparation of materials related to the report a letter of attorney as of date 15/07/2015 on behalf of Arpi Meras was submitted to advocate Hrant Ananyan to retain him powers to act in state and other bodies. Both in the crime report and the letter of attorney the signatures standing before the name of Arpi Meras do not seemingly have any generality with the signatures in the passport of Arpi Meras, as well as in the letter of attorney as of 22/10/2012 provided by Arpi Meras to Marina Poghosyan and in many other documents, in particular, those of Arpi Meras's found in the 29/09/2016 transcript of the face-to-face interrogation conducted between Arpi Meras and Marina Poghosyan and in the will made by Arpi Meras dated to 10/01/1994. The mentioned gives rise also to a

reasonable suspicion that in the crime report entered as of 20/07/2015 and that in the letter of attorney as of 15/07/2015, the signatures set before the name of Arpi Meras were not done by her but were falsified by a person or people other than Arpi Meras.

It is remarkable that reasonable suspicions on falsifications of signatures exist concerning the signatures made in the name of both Arpi Meras and her sons of Saro Mark Meras and Suren David Meras, which can testify that we have to do with a person or people for whom signing instead of other people in a right-retaining paper is a common practice.

Based on the above-presented and considering that two letters of attorney dated as of 17/02/2014 and 15/07/2015, presented by Hrant Ananyan, are right-retaining papers, I would like to ask you to accept this application as a crime report, to initiate a criminal case, to send the case to the relevant investigating authority to carry out the preliminary investigation for the identity of the alleged perpetrator and to give rise to the criminal liability.

In attach I am presenting (1) a copy of the letter of attorney dated as of 17/02/2018 - on one sheet of paper; (2) a copy of the passport of Saro Mark Meras - on one sheet of paper; (3) a copy of the passport of Suren David Meras - on one sheet of paper; (4) a copy of a crime report entered on 20/07/2015 by Yerevan City Department of the the RA Police – on two sheets of paper; (5) a copy of the letter of attorney as of 15/07/2015 - on one sheet of paper; (6) a copy of the letter of attorney provided on 22/10/2012 to Marina Poghosyan by Arpi Meras - on one sheet of paper; (7) a copy of the transcript of the face-to-face interrogation conducted on 29/09/2016 between Arpi Meras and Marina Poghosyan – on ten sheets of paper; and (8) a copy of the will dated to 10/01/1994 made by Arpi Meras – on five sheets of paper.
